To apply for transient status, the student must send an official transcript from his/her graduate school and have the dean complete Part III of this form (or write a letter stating that the student is in good academic standing) and return it to the address on the bottom of the page. Send a check or money order for the \$30 non-refundable application fee payable to Kent State University. The student will not be permitted to register for graduate credit at Kent State University until the Graduate School of Management has received this form and the application fee. An acceptance letter, if approved, will be sent. This admission is good for one semester only. Those who desire to take additional coursework must submit a new transient application and fee. Transient status is limited to a maximum of 12 semester hours.
